- How have national/racial/ethnic identities of the Baltic states developed since the dissolution of the USSR?

- What are the implication of the development of national identities in the postsocialist countries from comparative perspectives?
- What is the status of the Soviet cultural heritage now in Baltic States? How are the Soviet and socialist past, its cultural, material and intellectual heritages interpreted and assessed? Any new culture emerges?
- What are the postcolonial narratives in Central and East European literature and art?
- Is there any transnational circulation of identity narratives in Baltic States?
- What is the current status of Korean studies in Baltic countries and how have they developed since the independence of the Baltic States.
- What is the status of Korean culture now in Baltic countries?
